Spaces/areas will be made available for those who are joining us part time vs permanent spots for the full-time vendors. Each vendor will be notified of this arrangement prior to the beginning of the market season

Vendors will provide their own 10x10 tent (camping tents not allowed) and tables. Hampton Falls Farmers market does not provide tents or canopies. Tents should be in presentable and good repair, clean and attractive. NO TENT STAKES are permitted on the grounds, please use tent weights (recommended: 20 lbs per leg to sustain winds). Vendors with no tents will be permitted, please let us know in advance as there is a designated area for this.
